

## Data protection regulation

### Scope of validity

This data protection policy is intended to inform users of this website about which personal data is collected and used by the website operator [House of the Wannsee Conference Memorial], as required by the Federal Data Protection Act and Telemedia Act.

### Handling of personal data

The House of the Wannsee Conference Memorial collects, uses and shares your personal data only if this is permitted by law or you consent to it.

Personal data includes all information that can be used to determine your identity and which can be tracked back to you - such as your name, e-mail address and telephone number.

### Handling of contact data

If you contact the House of the Wannsee Conference Memorial via the available contact options, your details will be stored so that they can be accessed in order to process and reply to your request. This data will not be passed on to third parties without your consent.

Please note that data transmission via the internet (e.g. when communicating by e-mail) is subject to security gaps. Complete protection of data from access by third parties is not possible.

### Analysis services

#### *Google Analytics*

The websites of the House of the Wannsee Conference Memorial and Educational Site use the "Google Analytics" service provided by Google Inc. (1600 Amphitheatre Parkway, Mountain View, CA 94043, USA) to analyse how users use the websites. The service uses "cookies" - text files that are stored on your terminal device. The information collected by the cookies is generally sent to a Google server in the USA and stored there.

IP anonymisation is used on the website. The IP addresses of users within member states of the EU and European Economic Area are truncated. This truncation removes the possibility of your IP address being used to identify you. As part of the agreement on order-related data processing that the website operator has concluded with Google Inc., Google Inc. will use the collected information to provide an analysis of website use and website activity and will provide services associated with Internet use.

You have the option to block the storage of cookies on your device by making the relevant settings in your browser. It cannot be guaranteed that all of the functions of this website will be available to you without limitations if your browser does not allow cookies.

### Disclosure, deletion, blocking

You have the right at any time to obtain information about the personal data stored about you free of charge, along with its origin and recipients and the purpose of data processing, as well as the right to correct, block or delete this data.

## **SSL encryption**
